

No. 22-1, HD1 “To approve revenues and resources of the Commonwealth of the Northern Mariana Islands, as identified pursuant to Article III, Section 9(a) of the Constitution, as amended, and 1 CMC, Division 7, for Fiscal Year 2022, beginning October 1, 2021, and ending on September 30, 2022.”
2. H.B. No. 22-08, "To establish the level of funding for the Legislature and provide the Legislature with control of the expenditure of funds appropriated for its operations."
3. S.B. No. 22-02 “To amend 1 CMC § 2893(d) to give the mayors of the First and Second Senatorial District authority to concur on all OGM-SC applications, programs and funding for the First and Second Senatorial Districts; and for other purposes.
4. S.B. No 22-10 “To amend 1 CMC § 2804(c) to authorize the payment of the travel expense, airfare, car rental if a department car is not provided, and per diem, in advance of a scheduled meeting for the Department of Public Lands Advisory Board members.
5. S.B. No 22-24 “To establish guidelines for the CNMI’s membership in the Pacific Islands Development Bank; and for other purposes”.
6. S.B. No. 22-36 “To strengthen the tools and powers of the CNMI Government to promote and expand economic development and to establish the Commonwealth Economic Development Authority; and for other purposes”.
