



PAROLE SUCCESSES

& ACCOMPLISHMENTS

- > CNMI Board of Parole continues to maintain the Susupe Community Garden
- > Two (2) newly appointed Saipan Board Member
- > Secured two (2) new Operational Supervision vehicle
- > Two (2) additional FTE Officers Position
- Parole had four (4) parolees that were discharged this year and during their tenure with Parole, they had taken counseling courses and had completed it.
- The CNMI Board of Parole family increased with three new hires: Raymond Y. Dador (Assistant Parole Officer), Vicente D. Repeki (Assistant Parole Officer), Manny S. Ramon (Administrative Officer), and one Department of Corrections transfer, Vincent M. Taitano (Parole Officer III).
- > With the help of ARPA funds, the BOP office was able to build a much-needed extension at the rear of the office that both staff and parolees utilize as a work station and break area.
- ARPA funds were also very instrumental in purchasing necessary protective and life-saving Officer's equipment which range from: Bullet proof vests, Side arm extenders, Ammunition for service rounds, trainings, qualification and certification purposes.
- > ARPA funds also made it possible for the office to provide staff with brand new uniforms, as well as other officers gear needed to carry on operations.

NEEDS & CHALLENGES

- Funding has always been an issue in regards to the CNMI Board of Parole Office.

 ARPA has been an enormous help and blessing these past couple of years, that got a lot of "needs and challenges" accomplished, but it's a funding source that will cease this fiscal year.
- The Saipan and Northern Islands Legislative Delegation (SNILD) and the Criminal Justice Planning Agency (CJPA) have been very helpful to the CNMI Board of Parole Office in granting extra funding on a yearly basis, albeit through an application/granting process. Budget limits and number of applications also limit amount of funding given out by these two entities.
