About the Municipal Council

The Commonwealth of the Northern Mariana Islands Constitution under *Article Vl. Local Government, Section 6. Municipal Councils* created the municipal councils for Rota, Tinian and Aguiguan, and Saipan and the islands north of Saipan, to be composed of three members, elected at-large in the islands or islands to be served and on a non-partisan basis. Candidates for municipal council shall be at least twenty-one years of age, a resident of the municipality for at least three years and shall serve for a term of two years. Each council shall adopt its own Rules of Procedure.

In case of a vacancy the mayor of Saipan shall appoint the unsuccessful candidate with the next highest votes for the office in the last election. Otherwise, the mayor shall appoint the person from the third municipality to serve the term with the advice and consent of the Saipan and Northern Islands Legislative Delegation. This provision was exercised with the appointment of Council Secretary Danny I. Aquino who was appointed by the mayor to fill the third vacancy.

The SNIMC office was founded and located in the village of Chalan Kanoa, the capitol village of Saipan. However, the Council's new office has been in the works for construction after typhoon Soudelor devasted the islands in 2015 and left the Council office destroyed. Similarly, in 2018 super-typhoon Yutu added structural damage to the Kiosku Memorial building. Funding for the construction of the Municipal Council building and repair of the Kiosku memorial building came from the federal emergency management agency and capital improvement project grants, respectively. Unfortunately, due to unforeseen challenges beyond the Council's control, the construction of the building continues to experience delay.

In the meantime, the Kiosku memorial building underwent extensive repair and renovation during the fiscal year as featured in this report.

Today, the Council continues to utilize the limited space at the Kiosku memorial building for meetings. However, the Council utilize a temporary office located at the first floor Courtney's Plaza for its full office operation to serve the community of Saipan and Northern Islands through programs, services, and community outreach while the Kiosku building undergoes repairs, repainting and retrofitting to conform with the CNMI and federal governments coronavirus health and safety protocol.

THE ROUND HOUSE

This historic landmark, the "Round House" has been the platform venue for community meetings, including political campaigns since the Trust Territory government era, and prior to the establishment of the constitutional government in 1978. Today, this historic landmark continues to be utilized for community engagement, including students' afterschool gathering space.




The 16th SNI Municipal Council received its budget appropriations from three funding sources: Public Law 21-35 Budget Appropriations Act of 2021, Saipan Local Law 21-10, S.L.L. 22-10, and the American Rescue Plan Act (ARPA). Although the Council received less funding appropriation from local revenue generation. The Council received funding allocations from the American Rescue Plan Act "ARPA" appropriation through the Coronavirus State and Local Fiscal Recovery Funds (SLFRF) Final Rule 603 (b) funds and in the ARPA *Spending Plan* to maintain its office operation, personnel, and to continue the programs, projects, and services due to the economic impact of the COVID-19 pandemic in the CNMI. The following are a breakdown of the funding sources and allocations as well as graphs to help provide a clear picture of the allocations for personnel and operational expenses as envisioned in the mission, goals, and objective of the 16th SNIMC for the community and our constituents.

❖ Looking ahead the 16th SNI Municipal Council leadership continues its work on some of its unprecedented ground-breaking initiatives, including its work with the various departments and agencies on Capital Improvement Projects (CIP), and construction companies to ensure the continuity of the process towards the construction of the permanent home for the Municipal Council.

These initiatives include the completion and continuation of the CCTV School Bus-stop shelters Commemorative project at the selected pilot sites beginning at the inaugural and memorial site adjacent to the As Teo-Santa Lourdes school bus-stop shelter (Lot. 217-4-1R/W).

- ❖ The completion and continuation of the community outreach program two grant initiatives the Family Caregiver grant and Grandparent care grants.
- The completion and full utilization schedule of the community learning center by the community, targeting school-aged children and youth as afterschool continued learning and homework site.
- ❖ To secure full funding for the Three-years Comprehensive Study called for in Municipal Council Resolution 16SMC-02.
- Provide continued staff training and development on the new financial management system - MUNIS implemented by CNMI Department of Finance, as required by the department, and other trainings on employment enrichment programs.
- Full implementation and utilization of the Council's website for social media platform as venue for wider community engagement, and to provide access to public communication, information, and announcements: https://spnnimunicipalcouncil.com/.
- To continue community education on the proposed constitutional amendment in collaboration with the members of the Pacific Alliance of Municipal Councils (PAMC) to provide the municipal council's greater legislative constitutional power to enact and repeal municipal level ordinances, which shall be placed on the ballot in the next general election.
