In 2005, Public Law No. 14-63 created and established the Office of Homeland Security under the Commonwealth of the Northern Mariana Islands (CNMI) Office of the Governor. It was not until 2013 that Public Law No. 18-4 reorganized the Office of Homeland Security and the Office of Emergency Management unifying them to create the CNMI Office of Homeland Security and Emergency Management (HSEM).

### Local Funds

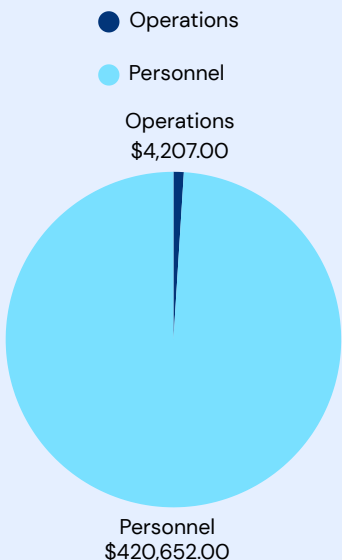
Through House Bill 24-46, HD1, SS1, entitled to “make appropriations for the operations and activities of the Government of the Commonwealth of the Northern Mariana Islands, its agencies, instrumentalities, and independent programs, and to provide budget authority for government corporations for Fiscal Year 2026; and for other purposes,” which was passed by the House of Representatives and the Senate of the Twenty-Fourth Northern Marianas Commonwealth Legislature became Public Law 24-14, CNMI HSEM has budgeted a total of \$424,859 in local funding.

**Total: \$424,859**





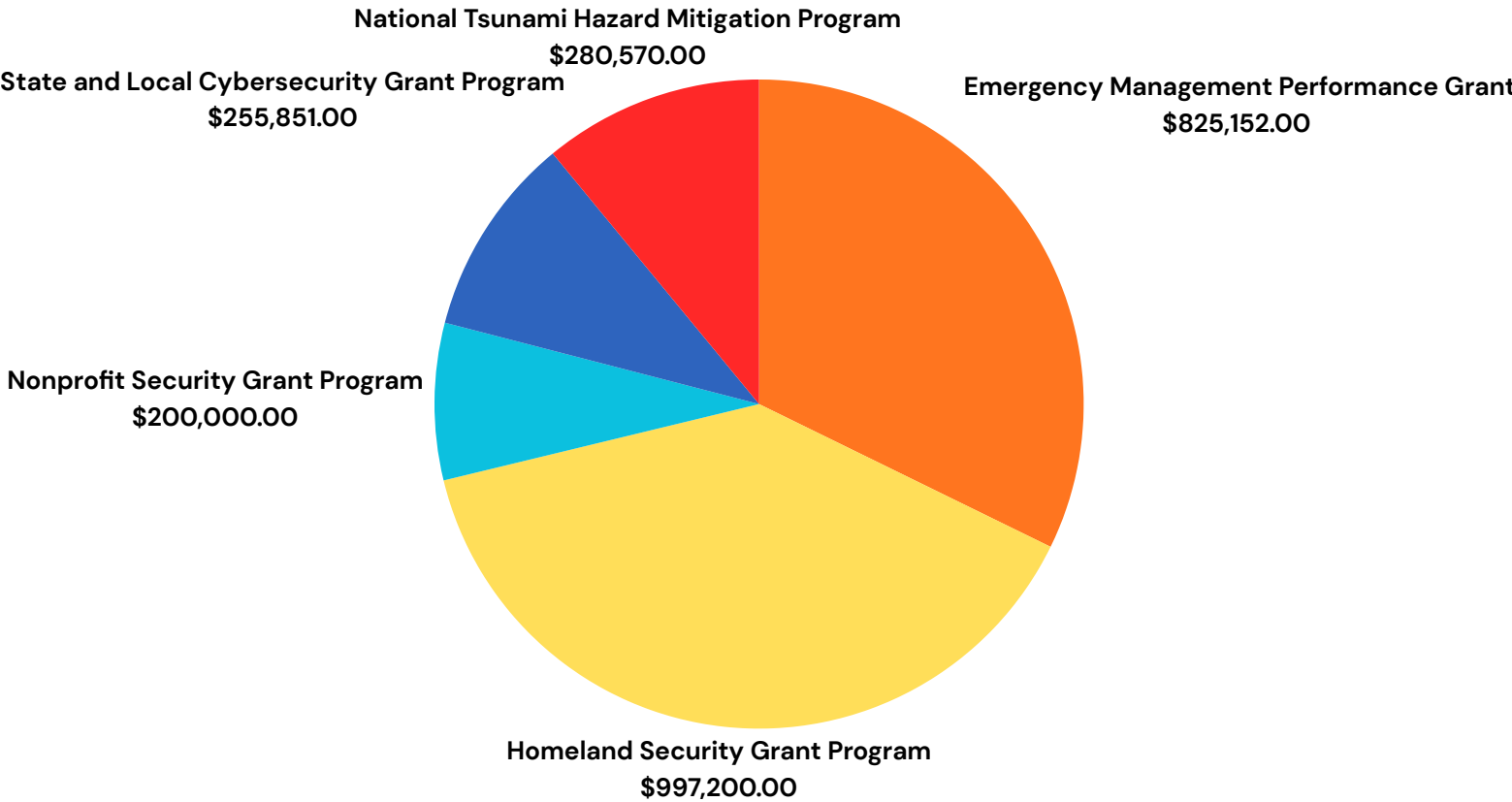
# FINANCES

## Federal Grants

In 2025, CNMI HSEM was awarded \$2,558,773 from the Emergency Management Performance Grant (EMPG), the Homeland Security Grant Program (HSGP), the Nonprofit Security Grant Program (NSGP), the National Tsunami Hazard Mitigation Program (NTHMP), and the State and Local Cybersecurity Grant Program (SLCGP).

| Due to austerity measures, CNMI HSEM projects and activities continue to be monitored and reviewed carefully.                                                                                                                                  | A U.S. federal government shutdown immediately strains the CNMI HSEM due to its heavy reliance on federal funding, primarily from FEMA preparedness grants. This disruption means that the approval of new grants for preparedness, equipment, and training is likely to be frozen or delayed. Additionally, the slower processing of reimbursements for past disaster costs puts immense pressure on the CNMI government’s already strained local finances. |
