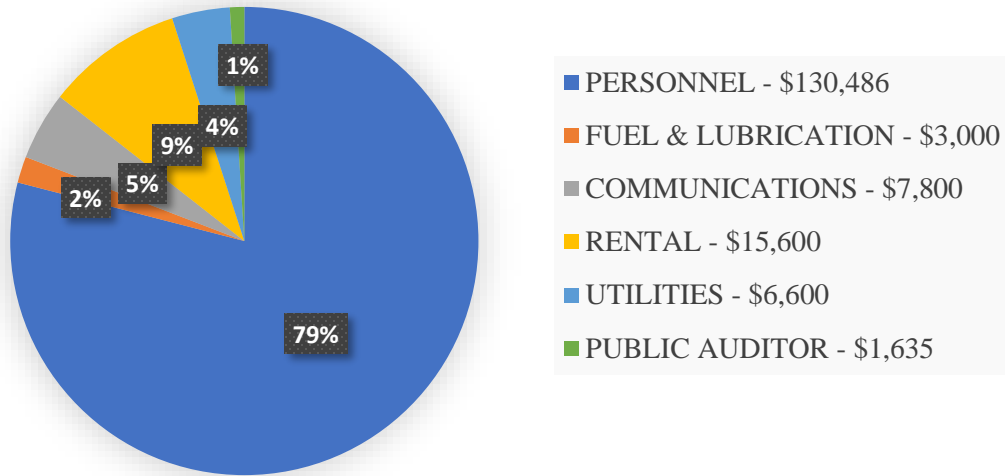

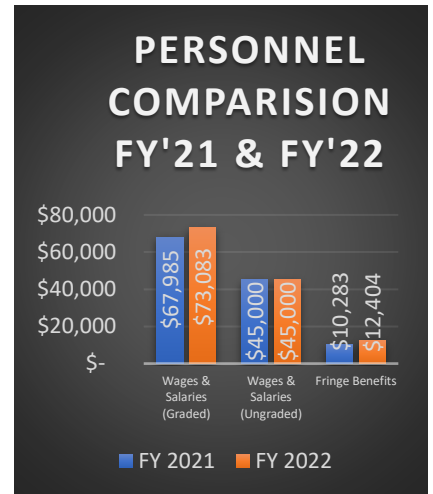
REVENUE & EXPENDITURES

FY 2022 BUDGET BREAKDOWN



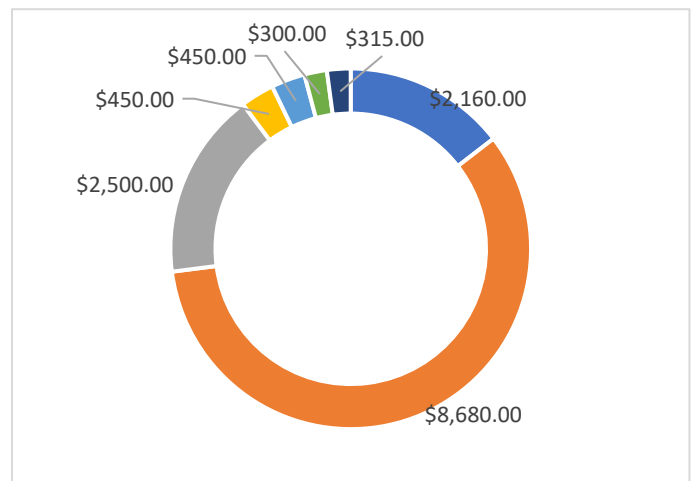
