I. <u>LEGISLATIVE HISTORY</u>:

- A. House Concurrent Resolution No. 23-2, entitled: "To approve revenues and resources of the Commonwealth of the Northern Mariana Islands, as identified pursuant to Article III, Section 9(a) of the Constitution, as amended, and 1 CMC, Division 7, for Fiscal Year 2024, beginning October 1, 2023, and ending on September 30, 2024.", was adopted by the House on July 7, 2023, during its First Day, Fourth Special Session.
- B. House Concurrent Resolution No. 23-2 approved \$172,564,623 as the total identified budgetary resources for FY 2024 and \$115,407,265 as the total local revenue and resources available for appropriation for the Commonwealth Government activities in Fiscal Year 2024.
- C. House Concurrent Resolution No. 23-2 was transmitted to the Senate on July 7, 2023.
- D. House Bill No. 23-66, the Appropriations and Budget Authority Act of 2024, was introduced by Representative Ralph N. Yumul on August 10, 2023.
- E. The House of Representatives passed House Bill No. 23-66 in the form of House Substitute 1 on August 10, 2023, during its First Day, Second Regular Session.
- F. The House of Representatives transmitted House Bill No. 23-66, HS1 to the Senate on August 11, 2023.
- G. The Senate made amendments to House Concurrent Resolution No. 23-2 and passed the measure during its 2nd Day, Second Regular Session on August 10, 2023, in the form of House Concurrent Resolution No. 23-2, Senate Substitute 1.
- H. House Concurrent Resolution No. 23-2, SS1 approved \$163,415,313 as the total identified budgetary resources for FY 2024 and \$115,407,265 as the total local revenue and resources available for appropriation for the Commonwealth Government activities in Fiscal Year 2024.
- I. The House of Representatives rejected House Concurrent Resolution No. 23-02, SS1 in its Second Day, Second Regular Session on August 18, 2023, and referred the legislation to a conference committee.
- J. The Conferees agreed upon \$163,415,313 as the total identified budgetary resources for FY 2024 and \$114,238,931 as the total local revenue and resources

available for appropriation for the Commonwealth Government activities in Fiscal Year 2024 and was duly adopted by both houses as House Concurrent Resolution No. 23-2, SS1, CCS1.

- K. The Senate made amendments to House Bill No. 23-66, HS1 and passed the measure during its 4th Day, Second Regular Session on September 11, 2023 in the form of House Bill No. 23-66, HS1, Senate Substitute 2.
- L. The Senate transmitted House Bill No. 23-66, HS1, SS2, to the House of Representatives on September 12, 2023.
- M. The House of Representatives rejected House Bill No. 23-66, HS1, SS2 in its Fourth Day, Second Regular Session on September 15, 2023, referred the bill to a conference committee and the House Speaker appointed its conferees. Please see Hse. Comm. No. 23-63.
- N. The Senate was informed of the House rejection on September 15, 2023 and the Senate President appointed its conferees. Please see Sen. Comm. (House) 23-51.
- O. On September 19, 2023, a Conference Committee Meeting was held in the House Chamber of the Honorable Jesus P. Mafnas Memorial Building, Capital Hill, Saipan, and continued for several days. The Conferees present deliberated and agreed upon the amendments reflected in this report.

II. <u>RECOMMENDATION</u>:

The Committee deliberated and focused its effort on major differences between House Bill No. 23-66, HS1, the House version, and House Bill No. 23-66, HS1, SS2, the Senate version. During the Conference Committee meetings, the primary issues discussed included but were not limited to the following:

- A. Section 403. Donation of Sick Leave
- B. Section 501. Reprogramming Authority
- C. Section 601. Utilities
- D. Section 602. Hiring Restrictions
- E. Section 604. Revolving Accounts
- F. Section 605. Legal Holidays
- G. Section 606. Marriage License Fee (HS1 version)
- H. Section 607. Fiscal Year Limitations (HS1 version)
- I. Section 606. Excepted Service Employee
- J. Section 703. Judicial Branch

- K. Section 704. Legislative Branch
- L. Section 706. First Senatorial District Mayor of Rota
- M. Section 707. Second Senatorial District Mayor of Tinian and Aguiguan
- N. Section 709 (e). CNMI Medical Referral Program (Health Network Program)
- O. Section 710 (e). Medicaid Program
- P. Section 802 (b). Compact Impact

- S. Mayor of Saipan NOP Funding Removal
- T. Mayor of Tinian and Aguiguan NOP Funding
- U. Appropriation of the savings realized from the reduction in work hours for the employees of the Judicial Branch, Legislative Branch, Elected AG, Public Defender
- V. Schedule "A" and Schedule "A" with detailed attachment.

Significantly, the Conferees agreed, among other items, to the following debated issues.

A. <u>Section 403. Donation of Sick Leave.</u> The Conferees agreed to the Senate version that added a new Section 403 that reads as follows:

"Notwithstanding any laws to the contrary, when an employee volunteers to donate sick leave, the donated sick leave shall be based on the donor's current base hourly salary and shall be converted into equivalent sick leave hours based on the recipient's current base hourly salary. Provided that the donated sick leave hours shall not exceed 1040 hours.

Conversion:

(Sick Leave Hours Donated) multiplied by (Donor's Hourly Base Rate) = (Donor's Donated Dollar Value)

(Donor's Donated Dollar Value) divided by (Recipient's Hourly Base Rate) = (Number of Hours Donated to Recipient)

Example: (Donor donated 100 hours) x (Donor's hourly rate of 20) = 2,000

(\$2,000) divided by (Recipient's hourly rate of \$10) = 200 hours to Recipient.

Based on the information provided to the Senate Conferee Chairman, the Office of Personnel Management stated that leave donated and then borrowed from the Designated Account will not require repayment of the borrowed leave therefore the Conferees agreed to keep the Senate's provision.

B. <u>Section 501. Reprogramming Authority.</u> The Conferees agreed to the Senate version that reads as follows:

(a) Notwithstanding <u>the 25% reprogramming authority pursuant to</u> <u>1 CMC § 7401(b)</u>, any law to the contrary, the Governor shall have up to <u>an-additional-50% 100%</u> reprogramming authority for the departments, agencies, and offices of the executive branch, provided that 50% of the available funds for the municipal entities shall not be subject to this reprogramming authority without the consent of the Mayor. Provided further that the reprogramming authority shall not apply to Section 604 of this Act. #Reprogramming shall not be used for _the hiring of personnel or salary adjustment of active personnel. This authority to reprogram shall not apply to the funds appropriated to the Legislative of Judicial Branches as well as to those funds appropriated by the respective legislative delegations.

In addition, the Conferees agreed to further amend this subsection beginning with giving the governor 100% reprogramming authority for the departments, agencies, and offices of the executive branch, provided that the municipal entities shall not be subject to this reprogramming authority without the consent of the Mayor. Lastly the Conferees added that the governors reprogramming authority shall not apply to Section 604 of this Act and further clarification with respect to the word "personnel" in the sentence that reads: "Reprogramming shall not be used for personnel" was amended to read: "Reprogramming shall not be used for *the hiring of personnel or salary adjustment of active* personnel".

C. <u>Section 601. Utilities.</u> The Conferees agreed to amend the House version subsection (a) and accept the Senate version that added a new subsection (c) that reads as follows:

(a) <u>Except as provided in subsection (c)</u>, <u>T</u>the CUC monthly utility billings <u>for all departments and agencies</u> shall be submitted to the Department of Finance in a timely manner for payment <u>paid by the central government after all the funds in the general revolving accounts are exhausted</u>.

(c) Except for the Judicial Branch and Legislative Branch, all utilities, including the municipalities of Rota, Tinian, Saipan and the Northern Islands, shall be paid by the central government. Provided that any shortfall of utility payments of the Judicial Branch and Legislative Branch shall be paid by the central government.

- D. <u>Section 603. Salary Cap.</u> The Conferees agreed to the House version of this section however disagreed on whether "Schedule A" or "Schedule A with the detailed attachment" would best compliment this provision. In light of the impending timeline, the House Conferees agreed to forego the detailed attachment of the House's Schedule A and accept the Senate version Schedule A.
- E. <u>Section 604. Revolving Accounts.</u> The Conferees agreed to the Senate version that reads as follows:

Subject to constitutional limits, notwithstanding any CNMI and/or local laws, regulations, and rules to the contrary <u>and except for the</u> <u>suspended accounts as provided in Section 202 and special revenue</u> <u>account</u>, all <u>general</u> revolving account <u>expenditure</u> limitations and restrictions <u>directing</u> relating to <u>the</u> scope of application or other subject matter requirements are hereby suspended <u>in FY 2024</u>. Accordingly, all legally established revolving accounts or business units and the funds therein may be expended by their respective expenditure authorities for the following operational expenses: fuel, <u>communications</u>, operational office supplies, and inter-island travel for training purposes without restriction and limitations. Provided further that Section 501 of this Act shall not apply to this section.

In addition, the Conferees agreed to make further amendments to ensure clarity involving specific revolving accounts. The additional amendments include the addition of "special revenue account" and to specify "general" revolving accounts and that Section 501 of this Act shall not apply to this section.

F. <u>Section 605. Legal Holidays.</u> The Conferees agreed to delete subsection (a) of the Senate version and further amend subsection (b) and (c) that reads as follows:

(a) <u>The governor may shall suspend the payment of up to five legal holidays</u> during Fiscal Year 2024, except for the Judicial Branch, Legislative Branch,

autonomous agencies, and all fully federally funded NOPs. Provided that the funds of the suspended holiday pay shall be reserved and deposited for the Group Health and Life Insurance (GHLI), BU 1528 Medicaid <u>Reimbursement, BU 1951.</u> The following laws and regulations providing for payment of legal holidays are suspended during Fiscal Year 2024:

(b) (a)Any employee required to work on a <u>suspended</u> <u>non-federal</u> <u>Commonwealth</u> legal holiday shall be paid <u>at the basic salary rate for the</u> <u>hours worked on that day without any additional adjustment for holiday</u> <u>leave with pay</u> <u>his/her regular salary</u>.

(c) (b) Provided that any employee whose salary is <u>partially or fully</u> paid in full by federal funds shall receive leave with pay for legal holidays.

The House version sets a floor and authorizes the Governor to select one or more legal holidays for FY24 for which employees shall receive leave with pay while the Senate version sets a ceiling and a condition that the governor may suspend the payment of up to five legal holidays during FY24, except for the Judicial Branch, Legislative Branch, autonomous agencies, and all fully funded NOPs provided that the funds of the suspended holiday pay shall be reserved and deposited for the Group Health and Life Insurance (GHLI). In order to reach a consensus and not suspend more than 5 legal holidays, the Conferees agreed to jointly push forward with tax bills because at this point, there is no other stream of revenue that can address the governments revenue shortfall except for tax hikes. Several tax bills that garnered the Conferees support include the tobacco tax increase; sugar sweetened beverage tax; container tax; betel nut tax; and pending further review of its language, the construction tax. The Conferees anticipate to pass most, if not all, to address the shortfall in Medicaid and GHLI and more importantly to prevent further reducing the work hours of our government employees.

The Conferees further agreed that an additional 2 hour reduction spread throughout the fiscal year will make adjusting to this additional cut easier on government employees. Therefore, government employees will be paid on holidays because 2 additional hours will be added to the already existing 8 hour reduction for a combined total of 10 austerity hours per pay period.

G. <u>Section 606. Marriage License Fee (House version).</u> The Conferees agreed that this provision should remain deleted and should be introduced as a stand-alone legislation.

- H. <u>Section 607. Fiscal Year Limitations (House version).</u> The Conferees agreed that this provision should remain deleted and should be introduced as a stand-alone legislation.
- I. <u>Section 606. Excepted Service Employee.</u> The Conferees agreed to the Senate version that reads as follows:

The legislature recognizes that there are employees who are on an Excepted Service Contract in the government, including the municipalities. Upon renewal of an excepted service contract, the employee shall not receive a salary increase.

J. <u>Section 607. Cell #1 Marpi Landfill Closure Financial Assurance Mechanism.</u> The Conferees agreed to add a new Section 607 to read as follows:

In the event of any funding shortfalls caused by this Appropriations Act, the CNMI Government shall be fully responsible for all costs and expenses, not to exceed \$5,400,000.00, that are necessary to effectuate the closure of Cell#1 of the Marpi Landfill.

The language was requested and approved by the Secretary of the Department of Public Works to provide for a financial assurance mechanism needed since the Solid Waste Earmark was suspended.

K. <u>Section 608. Reduction of Work Hours.</u> The Conferees agreed to add a new Section 608 to read as follows:

During Fiscal Year 2024, notwithstanding any laws or contractual provisions to the contrary, a full pay period for purpose of earning annual leave, sick leave, or other benefits, shall be 80 hours less the amount of hours deducted via austerity measures. This provision shall not apply to first responders and law enforcement personnel, whose normal work exceeds 80 hours per pay period.

The Conferees agreed that additional language was necessary to ensure that hours deducted via austerity measures will not affect the earnings of annual leave, sick leave, or other benefits for government employees.

L. <u>Section 703. Judicial Branch.</u> The Conferees agreed to the Senate version that amended subsection (b) and added new subsections (c) and (d) that reads as follows:

(b) Notwithstanding 1 CMC § 7204 (e), funds appropriated for Fiscal Year 2024 to the Judicial Branch shall be allotted monthly. Provided that the allotment request for the last month of the fiscal year shall be made no later than August 1st and the requested advance shall be remitted on or before August 15th.

(c) Notwithstanding any laws to the contrary, the Chief Justice of the CNMI Supreme Court and Presiding Judge of the CNMI Superior Court may adjust the Judicial Branch work schedule and operating hours that are consistent with available funds for personnel and operations.

(d) The Chief Justice and the Presiding Judge may use any available outside source funds, including revolving accounts, to restore the reduced work hours of the Judicial Branch personnel.

In addition, the Conferees agreed that in addition to any available outside source funds, that the Judiciary Branch may also use any available revolving account funds to restore the reduced work hours of the Judicial Branch personnel.

M. <u>Section 704. Legislative Branch.</u> The Conferees agreed to the Senate version that added new subsections (c) and (d) that reads as follows:

(c) Notwithstanding any laws to the contrary, the <u>President of the</u> <u>Senate and the Speaker of the House of Representatives Legislative</u> <u>Bureau Director may adjust the Legislative Branch work schedule</u> and operating hours that are consistent with available funds for personnel and operations.

(d) The Legislative Bureau Director may use any available outside source funds to restore the reduced work hours of the LB personnel.

The Conferees agreed to give the Director of the Legislative Bureau the authority to adjust the Legislative Branch schedule and operating hours that are consistent with available funds for personnel and operations, therefore an additional amendment was made to subsection (c).

Accordingly, the insertion of these provisions renumbers the succeeding subsections in this section.

N. Section 706. <u>First Senatorial District – Mayor of Rota and Rota Municipal Council</u> The Conferees agreed to the Senate version that added a new subsection (b) that reads as follows:

> (b) <u>The three NOPs shall be provided to the Rota Customs Services</u> for Customs Inspector positions, BU 1152. Upon the hiring of these three new positions the three NOPs under the Office of the Mayor of Rota shall be unfunded and removed.

O. Section 707. <u>Second Senatorial District – Mayor of Tinian & Aguiguan and Tinian</u> <u>Municipal Council.</u> The Conferees agreed to the Senate version that added new subsections (b), (c) and (d) that reads as follows:

> (b) <u>\$531,277</u> shall be transferred from the Tinian Municipal Treasury to the Commonwealth government to partially fund the salaries of the 24 employees under the Tinian Mayor's Office who are not fully funded in this Act, provided that the Tinian Municipal Treasury transfers each month the required two biweekly payments for the 24 employees. The Municipal Treasury shall provide a list of the 24 affected employees.

> (c) One new NOP shall be funded under BU 1485 at \$1 \$29,551 for a Landfill Supervisor for the Department of Public Works-Tinian.

> (d) Unfunded personnel under Department of Public Safety-Tinian and Department of Fire and Emergency Medical Services-Tinian shall be funded an additional \$1 each.

The House conferees had some concerns with respect to subsection (b), however since the funds in question were outside sourced funds thus the House conferees accepted the language. In addition, the Secretary of Finance informed the Senate conferees that transferring the funds to the general fund account would be the best approach solution.

Lastly, the Conferees agreed to fully fund the Landfill Supervisor for the Department of Public Works-Tinian, therefore the actual salary was inserted in subsection(c).

P. Section 709. <u>Other Programs.</u> The Conferees agreed to the Senate version that amended subsection (e) that reads as follows:

(e) CNMI Medical Referral Program (Health Network Program). The Commonwealth Healthcare Corporation shall administer the CNMI Medical Referral Program or its successor, including both inter-island and off-island referrals, consistent with its duties and responsibilities under 3 CMC § 2821 *et seq*. More specifically, the inter-island medical referral services shall include stipends, airfare, and lodging for patients and escorts, which is consistent with the off-island medical referral program. The expenditure authority for all funds appropriated to inter-island and off-island medical referral services of BU 1979, 1979A, and any new business units established for CHCC Medical Referral) shall be the CEO of the Commonwealth Healthcare Corporation or designee.

Q. Section 710. <u>Independent Programs.</u> The Conferees agreed to the Senate version that amended subsection (e) that reads as follows:

(e) Medicaid Program. The funds appropriated in this Act for the Medicaid Program, including Medicaid Reimbursement, BU 1951, Medicaid Agency, BU 1980, and Medicaid Enterprise Systems (MES), BU 1981 shall be deemed a single budget reserved for the purposes of Medicaid Agency, Medicaid Reimbursement, and Medicaid Enterprise Systems. The Director of the Commonwealth Medicaid Agency may reallocate the funds appropriated in this Act to any of the expenditure categories, including, but not limited to, Agency, Reimbursement, and Medicaid Enterprise Systems. Provided further that for the Fiscal Year 2024, pursuant to the request of CNMI Medicaid, with the concurrence of the Office of Personnel Management, notwithstanding any other law to the contrary, all of the 11 NOPs for the Medicaid Enterprise Systems & Health Information Technology funded under BU 1981 shall be excepted service contract employees.

The Senate Conferee Chairman informed the conferees that the Medicaid Office specifically requested that the identical language that was used in the FY23 budget be included in this year's budget.

R. Section 802. <u>Outside Sources.</u> The Conferees agreed to the Senate version that deleted the Compact Impact funds in its entirety. The Senate Conferee Chairman informed the conferees that the Secretary of Finance verified and confirmed that the CNMI will not be receiving Compact Impact funds for FY24.

- S. <u>Schedule A or Schedule A with detailed attachment.</u> The Conferees agreed to the Senate version of Schedule A and to forgo the House's detailed attachment. Amendments agreed upon will be reflected in the Senates Schedule A.
- T. Amendments made to the Senate version of Schedule A, as provided by the House Fiscal Analyst:

The Conference first addressed the matters related to Schedule A by reducing personnel allocations to departments and agencies by 5 holidays or 40 hours to their total 2,080 hours that comprises of a full year's working hours. The total reduction for the 5 holidays will thus be taken and placed into the Medicaid Reimbursement business unit.

Secondly, the committee agreed to use the monies under the Active Employees, Health Insurance Employer Contributions business unit to fund the following:

- The Saipan Mayor's Office in the amount of \$690,904 for their personnel.
- The Rota Mayor's Office in the amount of \$100,000 for their operations.
- The Division of Customs & Bio-Security in the amount of \$46,684 for 1 NOP.
- The Solid Waste Management Division in the amount of \$28,773 for 1 NOP.
- The Retirees GHLI business unit in the amount of \$73,025.

The Members of the Conference Committee are in accord with all the amendments made. Therefore, the Conference Committee recommends that the House and Senate pass House Bill No. 23-66, HS1, SS2 in the form of House Bill No. 23-66, HS1, SS2, Conference Committee Substitute 1 upon the adoption and the acceptance of this Conference Committee Report.

The Conference Committee shall dissolve upon House Bill No. 23-66, HS1, SS2, CCS1 becoming law.

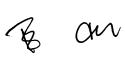
